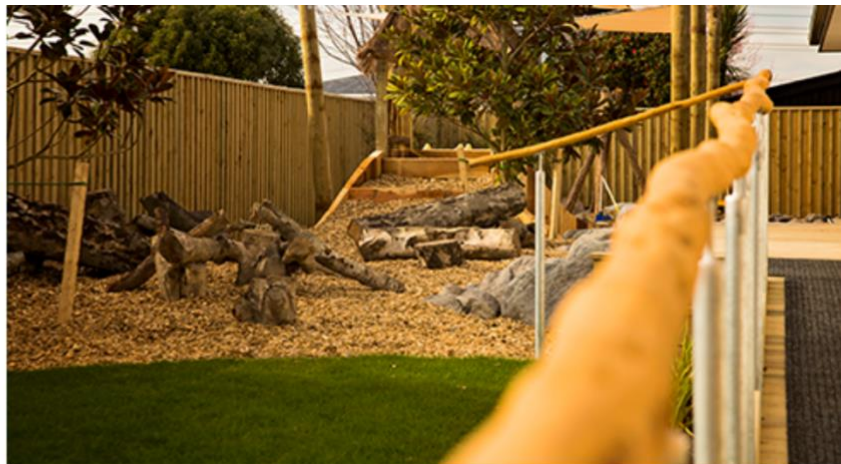
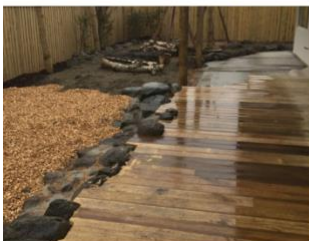

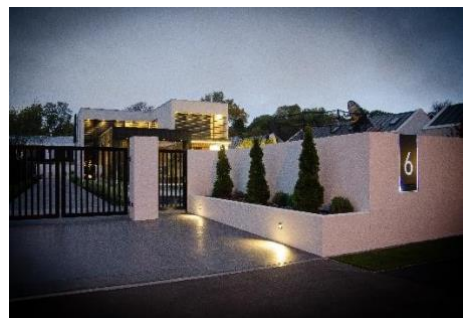


LITTLE BLUE PENGUIN EARLY LEARNING CENTRE
